2. Entry into the competition will be deemed as acceptance of these terms and conditions. Entries must comply with these terms and conditions to be valid.
3. This competition is available to past *Life!* participants, this includes anyone who has registered for, and has completed the introductory session of, the *Life!* Program course.
4. The competition begins at 9.00am on Thursday 8 December 2016 and closes at 5.00pm on Friday 31 March 2017. After this date and time, no further entries to the competition will be accepted.
5. To be eligible to enter, an individual must:
  - a. Be a past *Life!* program participant; and
  - b. Complete the *Life!* program health check at the Diabetes Expo 2017 on Saturday 25 February 2017 between the hours of 9am – 5pm; or
  - c. Participate in follow up data collection, either online or via phone; and
  - d. Provide their email address upon request (winners will be notified by email); and
  - e. Be an Australian resident aged 18 years old or over as at the competition launch date.
6. Entries will not be accepted by any other method.
7. Entries by companies, groups or other associations will not be accepted.
8. Employees of Diabetes Victoria or their family members and/or anyone else connected in any way with helping to coordinate the competition are not permitted to enter the competition.
